Set your page as A4 size Paper, margins as follows:

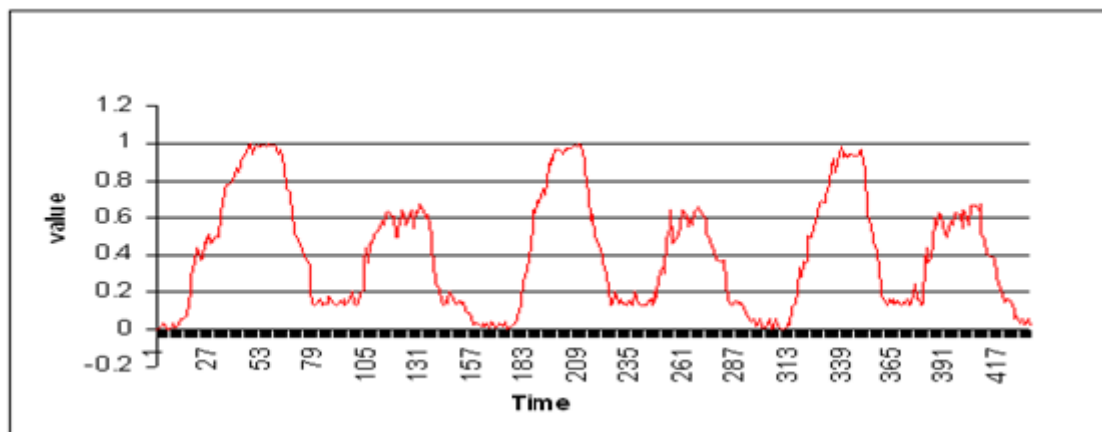
- Left Margin 1 Inch (1.00")
